Information for authors:

Rules of articles publications.

General

The journal publishes original articles containing the results of fundamental and applied researches.

Submitted works must contain new, previously unpublished data. Topic of the article must compliant with journal specialization, and of course, article must present relevancy, novelty and importance of the submitted materials.

The manuscript should be designed in strict accordance with the rules for the articles.

The editorial Board has the right to make editorial changes to the manuscript, which are agreed with the corresponding author at the stage of acceptane of the article.

Requirements for text design

The manuscripts should be presented in MS Word for Windows (*.doc) or docx: times New Roman font, size 14, line spacing 1.5, page margins - 20 mm on all sides. The permitted volume of the manuscript of the article (including tables and figures) is not more than 8 pages. The increase in the volume of the manuscript is possible in agreement with the editorial Board.

UDC (universal decimal classification index) is determined by the authors themselves .

DOI (Digital identifier of the object) is determined by the editors, after the sign of the contract.

Title of the article.

The title is written in russian and english (at the end of the article, after the conclusions), should be as clear and informative as possible. Words shortenings and abbreviations should be avoided if possible.

Photo of the author: should be in the text of the article and in a separate file attrached.

Authors information.

Initials and surname of the author, place of work. (in russian and english)

At the end the full postal address of the organization, e-mail of the author (s) is specified. (after the list of references). You must also specify the contact person with whom to correspond.

Abstract

Is submitted in russian and english. The abstract is a source of information about the content of the article and the results set out in it. It should be clearly structured and contain the following sections: relevance and objectives, materials and methods, results, conclusions. The allowed volume of the abstract is 200-250 words, up to 2000 characters including spaces. The text should be precise and clear, free from secondary information.

Keywords.

You must specify from 5 to 10 keywords in russian and english. Keywords should reflect the information presented in the article and ensure effective recognition of the subject by the search technical systems.

Design of the main text of the article.

The text of the article should have internal headings. The standard structure of the article includes: Introduction, Material and methods, Results, Discussion, Conclusions. Review articles, short communications, structures of any other forms may differ.

Introduction

It is necessary to specify the relevance and purpose of the study, a clear description of the scientific problem, indicating the reasons for the need to solve it in the existing conditions. It is advisable to show the scientific novelty and advantages of the proposed approach.

Materials and methods

This section should provide information about the objects of research, procedures, methods of measurement and data processing. At the same time widely known scientific methods should not be described in detail, preferring the author's methods, independently developed and previously unpublished.

Results

This section should present experimental or theoretical data obtained in the work. The results are given in the processed version: in the form of tables, graphs, organizational or structural diagrams, equations, photographs, drawings with short summarizing comments, comparisons, statistical data.

Discussion

This section provides a comparison of the original data presented in the article with the existing views in this field.

Summary

The main findings of the study should be clearly stated, consistent with the goals and objectives of the work, and their importance and relevance should be explained.

Design drawings

Figures (in color or grayscale, Times New Roman font) are placed in the text of the article with a sequence links to them. Numbers of figures are subsequent. The axes of the graphs are accompanied by captions reflecting their essence.

Drawings should be accompanied by captions, which are placed below them and aligned in the center.

The word "picture" is written in abbreviated regular shift, without highlighting. Reduction of words in figures is not allowed (except generally accepted). After the number of drawing a dot. For example:

Pic. 1. Results of classification of communities by species composition.

All drawings should be presented as separate files (raster drawings in JPG, TIFF, GIF, PNG, BMP, c 600 DPI resolution, vector drawings in CoralDraw, Excel, AdobeIllustrator).

The figures should have a minimum number of letters and numbers with obligatory explanation in the captions or in the text. Publication of drawings in the publication-in grayscale.

Table layout

Creation and formatting of tables are carried out in automatic mode (font Times New Roman, size 14, for volume 12). Tables are placed in the text of the article and numbered in the order of the presence in the text, numbering subsequent. Reduction of words in the tables is not allowed (except for the generally accepted). The word "table" is written completely in the usual font and is aligned to the right, after the number of the table the point is not put. The titles of the tables are placed below and centered

Formulas

Formulas are numbered only if further in the text the author makes a reference to them. Formulas in the text of the article are performed in the Microsoft Equation formula editor of the Microsoft Word text editor or the MathType program (font Times New Roman, size 14). All variables must be decrypted.

Indexes and measures of the same order must be strictly aligned in each row of the formula.

When specifying units of measurement, the generally accepted international system of units and abbreviations should be used.

Making a list of references and placing them in the text.

The authors are responsible for the accuracy and completeness of references to literary sources, as well as for the accuracy of citations presented in the text. All references are in the original language.

In connection with the new requirements for peer-reviewed journals, the terms for accepting articles in the current issue have been changed:
