Information for authors:

Publishing rules for "International Bulletin of Veterinary Medicine".

General Information.

The journal publishes original articles containing the results of fundamental and applied research.

Submitted papers must contain new, previously unpublished data. In addition, topic of the article must correspond to the subject of the journal, must contain relevance, novelty and importance of the materials presented.

The manuscript must be designed in strict accordance with the requirements for the design of articles.

The editorial board posses the right to make editorial edits to the manuscript, which are agreed with the corresponding author at the stage of proofreading the article.

Requirements for the design of the text.

Manuscripts are processed in the MS Word for Windows (*.doc) or docx editor: Times New Roman font, size 10, line spacing 1.0, page margins - 20 mm on all sides.

The permissible volume of the manuscript of the article (including tables and figures) is no more than 8 pages of computer text.

An increase in the volume of the manuscript is possible in agreement with the editorial board.

Structure of the article:

UDC: the authors determine (Universal decimal classification index) personally. It is highlighted in bold, put a colon, capital letters. Size 14.

DOI: (Digital identifier of the object) is determined by the editorial office, free of charge. It is highlighted in bold, put a colon, capital letters. Size 14.

TITLE OF THE ARTICLE (In bold, capital letters) Size 14.

The name is indicated in Russian, it should be as simple and informative as possible. Abbreviations should be avoided whenever possible.

Information about the authors:

Full name of the author (academic degree, academic title, position, ORCHID). The academic degree and title are prescribed according to the abbreviation. The author's full name is highlighted in bold, lowercase font. Size 10.

Place of work (without abbreviations). It is written in lowercase letters.

E-mail of the author, with whom the editorial board of the journal should correspond to. An asterisk (*) is indicated before the email. It is also placed by the author. Size 10.

Keywords in Russian and English. It is necessary to specify from 5 to 10 keywords. Keywords should reflect the information presented in the article and ensure

effective recognition of the topic by search tools. In Italics, lowercase letters. Size 10.

Financing. Thanks. Italics, lowercase letters ar highlighted. Size 10.

The date of receipt of the article by the editorial office is set by the author. Accepted for publication and published by the online editorial office of the journal. Size 10.

ABSTRACT (Highlighted in bold, uppercase letters)

It is provided in Russian. The abstract is a source of information about the content of the article and the results presented in it. It should be clearly structured and contain the following sections: relevance and goals, materials and methods, results, conclusions. The permissible volume of the abstract is 200-250 words, up to 2000 characters including spaces. At the same time, the text should be concise and clear, free of secondary information. The main sections of the article, materials and methods, results and conclusions should be reflected.

Design of the main text of the article.

The text of the article should have an internal heading. The standard structure of the article includes: Introduction, Materials and methods, Results, Conclusions. Review articles, short reports and some other forms may have a different structure (in agreement with the editorial board of the journal).

INTRODUCTION (Bold, capital letters)

It is necessary to indicate the relevance and objectives of the research, a clear description of the scientific problem with an indication of the reasons for the need to solve it in the existing conditions. It is advisable to show the scientific novelty and advantages of the proposed approach.

MATERIALS AND METHODS (Bold, capital letters)

This section should provide information about the objects of research, procedures, methods of measurement and data processing. At the same time, well known scientific methods should not be described in details, giving preference to the author's methods, independently developed and not previously published.

RESULTS (Highlighted in bold, uppercase letters)

Experimental or theoretical data obtained in the work should be presented in this section. The results are given in the processed version: in the form of tables, graphs, organizational or structural diagrams, equations, photographs, drawings with short summarizing comments, comparisons, statistical estimates.

CONCLUSIONS (Highlighted in bold, uppercase letters)

This section provides a comparison of the original data presented in the article with the available representations in this area. The main conclusions of the study should be clearly indicated, corresponding to the goals and objectives of the work, as well as an explanation of their importance and relevance.

THE TITLE OF THE ARTICLE (Highlighted in bold, capital letters)

Full name of the author (academic degree, academic title, position, ORCHID).

Place of work (without abbreviations). It is written in lowercase letters.

E-mail of the author, whom the editorial board should correspond to. An asterisk (*) is indicated before the email. The author also places it.

Financing. Thanks. (Funding) Italics, lowercase letters are highlighted.

ABSTRACT (Bold, uppercase)

The exact translation of the abstract in 200-250 words in English.

LIST OF SOURCES (Bold, capital letters)

REFERENCES (Highlighted in bold, uppercase letters)

REQUIREMENTS FOR FIGURES, TABLES

Drawings

(In color, Times New Roman font) are placed in the text of the article in a sequence of links to them. The numbering of the drawings is continuous. The axes of the graphs are accompanied by captions reflecting their essence. Drawings should be accompanied by captions, which are placed under them and aligned in the center.

The word "Drawing" is written abbreviated in the usual font, without highlighting. Abbreviations of words in drawings are not allowed (except for generally accepted ones). A dash is placed after the drawing number.

For example:

Fig. 1 – Results of classification of communities by species composition.

All drawings should be submitted in JPG, TIFF, GIF, PNG, and BMP formats, with a resolution of 600 DPI, vector drawings in Coral Draw, Excel, and Adobe Illustrator format).

The figures should have a minimum number of alphanumeric and numeric designations with mandatory explanation in the captions or in the text.

The publication of drawings in the publication is in grayscale.

Design of tables.

Tables are created and formatted automatically (Times New Roman font, size 14, for volume 12). Tables are placed in the text of the article and numbered in the order of mention in the text, numbering is continuous. Abbreviations of words in tables are not allowed (except for generally accepted ones).

The word "Table" is written in full bold, lowercase letters and aligned to the right, no dot is placed after the table number. The names of the tables are placed below and aligned in the center.

Formulas

Formulas are numbered only if the author makes a reference to them later in the text. Formulas in the text of the article are executed in the Microsoft Equation formula editor of the Microsoft Word text editor or the Math Type program (Times New Roman font, size 14). All variables must have a decryption. Indexes and indicators of the same order must be strictly aligned in each row of the formula. When specifying units of measurement, it is necessary to use the generally accepted international system of units and abbreviations.

Making a list of sources and References

Registration of lists of software sources (Vancouver reference style) and links in the test according to GOST R 7.0.7–2021. Sources are not 15 pieces.

The authors are responsible for the accuracy and completeness of the submitted references to literary sources, as well as for the accuracy of citations presented in the text. All references are provided in the original language.

Sequential numerical style: references are numbered in the course of their citation in the text, tables and figures; in the text, references are placed in square brackets. Sources in the list of references are numbered according to the order of their mention in the text, and not alphabetically.

The names of foreign magazines and books should be put in the original.

Self-citation of the author is allowed no more than 30% of the sources in the list of references.

In References, the language of the article is indicated in parentheses at the end. (In Russ.)
